NOTICE: A school tuition organization cannot award, restrict or reserve scholarships solely on the basis of donor recommendation. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent. Consult your tax advisor for specific tax advice.



Thank you for supporting Jewish day school education for the children in our community. You may take the 2020 tax credit for up to \$1,183 single/\$2,365 married couples - there is not a minimum. In addition to the individual tax credit, businesses that file as a C-corporation or an S-corporation and insurance companies can also take the credit; call our office for details.

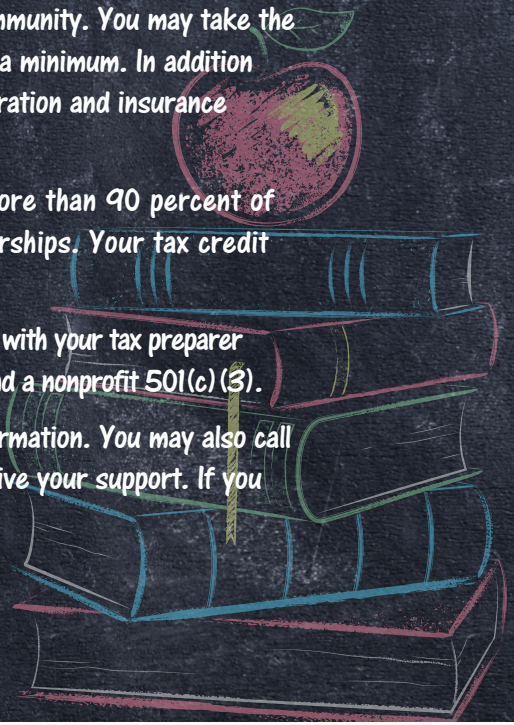
