In addition to the individual tax credit, businesses that file as a C-corporation or an S-corporation and insurance companies can also take the credit; call our office for details.

We support more than 65 percent of the students in our six schools with more than 90 percent of the dollars we raise. Since 1999, we have awarded more than 7,000 scholarships. Your tax credit dollars are well spent on scholarships.

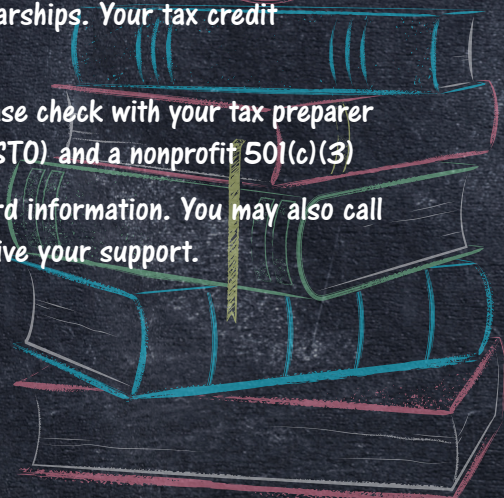
