In addition to the individual tax credit, businesses that file as a C-corporation or an S-corporation and insurance companies can also take the credit; call our office for details.

A minimum of 90 percent of the dollars we raise are directed to scholarships for students attending Jewish day schools. Making a difference for a child today will echo throughout the community for years. Your tax credit dollars are well spent on scholarships.

Your support is a dollar-for-dollar tax credit against your Arizona taxes. Please check with your tax preparer regarding federal tax deductions. The JTO is a School Tuition Organization (STO) and a nonprofit 501(c)(3).
